FBCSO Arrests Four in Undercover Operation Targeting Online Predators

(FORT BEND COUNTY, TEXAS) – In a continued effort to protect children from online exploitation, the Fort Bend County Sheriff's Office Internet Crimes Against Children and Human Trafficking /GANG Unit conducted a proactive undercover chat operation on July 30 and July 31, 2025. The operation targeted adults who use the internet and social media platforms to solicit sexual acts from minors.

As a result of the operation, four individuals were arrested and face the following charges. Dominique Smith, 38, was arrested and charged with Online Solicitation of a Minor. Hossam Hasan Farraq, 35, was arrested and charged with Online Solicitation of a Minor, Evading in a Motor Vehicle, and Unlawful Carrying of a Weapon (UCW). Luis Rodriguez, 36, was arrested and charged with Online Solicitation of a Minor. Marc Anthony Fuentes, 33, was arrested and charged with Online Solicitation of a Minor and Possession of a Controlled Substance (PCS). This multi-day operation was made possible by the coordinated efforts of detectives within the HT/ICAC/GANG Unit, who were supported by members of the Sheriff's Office Crime Reduction Unit (CRU), contributing to surveillance, arrest, and transport assistance. Additionally, the Auto Theft Unit provided drone air support to enhance operational safety and efficiency. The Fort Bend County Sheriff's Office is grateful for the inter-agency collaboration that contributed to the success of this initiative. Assisting agencies included the Fort Bend County District Attorney's Office, Missouri City Police Department, Richmond Police Department, and Sugar Land Police Department.

"Our top priority is the safety of our children," said Sheriff Eric Fagan. "These arrests serve as a strong reminder that we will not tolerate those who attempt to exploit our youth. I'm proud of our team and grateful for our law enforcement partners who share this mission."
