## Fort Bend County Sheriff's Office Celebrates Promotions and Awards

**(FORT BEND COUNTY, TEXAS)** – The Fort Bend County Sheriff's Office (FBCSO) recently recognized several men and women within the department for their commitment to public safety and excellence in service.

The Promotions and Awards Ceremony was held at the Gus George Law Enforcement Academy on Wednesday, December 10, 2025.

Lieutenant John Williams earned his basic TCOLE license at Brazosport College, joining FBCSO in 2011 as a reserve deputy. He began full-time Detention work in 2012. As Deputy, he served as Field Training Officer (FTO), Special Response Team member, and Special Response Team instructor. Promoted to Sergeant in 2018, he served in the Detention Division, obtaining his TCOLE Instructor License, later completing the FBI LEEDA Supervisor Leadership Institute.

Sergeant Austin Eaton brings a unique background to his role, beginning his public safety career in 2005 as a paramedic, where he served as a FTO and In-Charge Paramedic with specialized expertise in Tactical EMS, Hazardous Materials, and Rescue Operations. In 2010,

he transitioned to Telecommunications Operator and Patrol Officer, gaining experience in patrol, field training, SWAT, air support, crash reconstruction, and firearms instruction. He also taught the Gus George Law Enforcement Academy. Sergeant Eaton holds multiple licenses, including Paramedic, Advanced Peace Officer, Telecommunicator, and Jailer. He serves as a SWAT team Assistant Leader and Marksman. He is a certified drone pilot and firearms instructor for ALERRT and less-lethal munitions.
